During the workshop, members discussed the procurement process of renewable energies, updates on rules, laws and policies, and upcoming projects and opportunities for the private sector, such as net metering. Experts from key institutions in the renewable energy sector, including MEW, MRRD, and DABS, hosted group discussions with participants at different tables and shared their knowledge.
